Please review, sign your registration form to confirm you agree with the policies below.

Payment Policies:

- A \$75.00 deposit (non-refundable) is required with your registration form to secure your spot.
- The balance is due 1 week prior to the camp start date.
- Due to limited enrolment, if we do not receive the balance of your camp fee one week prior to the start date of the camp, you will risk losing your spot to someone on the waiting list and/or late fees will be applied to your account. Late fee penalty one week prior to the start date is \$15.00 plus tax.
- Receive 10% off if you register and pay in full on or before April 1, 2024

 We accept cash, chq, etransfer (barriedance2@gmail.com) and credit card (click the invoice)
- There is a 30\$ fee for chqs that are returned from the bank NSF
- · All prices are subject to hst (13%)

Cancellations:

- · Cancellation notices must be received by email.
- · Cancellations received more than 1 week (7 days) prior to the start date will receive a full refund (not including the non refundable deposit).
- Due to limited enrollment and wait lists, cancellations received less than 1 week (1-6 days) prior to the start date will be subject to a \$25.00 cancellation fee per week and will receive the rest as a refund or can remain as credit on your account. (not including the non refundable deposit)
- Please allow 3-4 business days to process your cancellation.
- · Refunds will not be given once the camp week has started.

The Barrie Dance Conservatory reserves the right to close facilities, to change instructors, to cancelany program with insufficient enrollment or to combine programs in which attendance falls below theminimum number required to run a program. We will notify you immediately of any such changes.

Program Removal:

I understand and agree that intentional participant behavior that puts the participant or others at physical or emotional risk may result in immediate dismissal from the program. Any expenses incurred because of program dismissal will be the responsibility of the participant / parent / guardian.Parents/guardians or a suitable designate must be available to pick up participants should the participant be dismissed from his / her program.
