Fees & Policies – March Break Camp Registration

Payment Policies:

- Full Payment is required with the registration.
- Receive 10% off – Full Camp Week Only and if you register and pay in full on or before Feb 15, 2024
- Due to limited enrolment, we do not hold spots. Registration is only confirmed once payment is received.
We accept cash, chq, etransfer (barriedance2@gmail.com) and credit card.
- There is a 30\$ fee for chqs that are returned from the bank NSF
- All prices are subject to hst (13%)

Cancellations:

- Cancellations (Full week registration and Day Camp registration) made one week (7 days) prior to the camp start date will be refunded in full.
- Cancellations (Full week registration and Day camp registration) made within 1-6 days prior to the camp start date will receive a refund minus a \$25.00 admin fee.
- Please allow 3-4 business days to process your cancellation.
- Space is limited and we will have a wait list. Your cancellation on short notice could affect the ability for another child to join the camp week. Please be considerate and provide proper notice so that BDC can properly secure other registration in a timely manner.
- Refunds will not be given once the camp week has begun.

The Barrie Dance Conservatory reserves the right to close facilities, to change instructors, to cancel any activity with insufficient enrollment or to combine programs in which attendance falls below the minimum number required to run a program. We will notify you immediately of any such changes.

Program Removal:

I understand and agree that intentional participant behavior that puts the participant or others at physical or emotional risk may result in immediate dismissal from the program. Any expenses incurred because of program dismissal will be the responsibility of the participant / parent / guardian. Parents/guardians or a suitable designate must be available to pick up participants should the participant be dismissed from his / her program.
